SELECTION FOR THE POSTDOCTORAL GRANT OF THE PNPD PROGRAM (CAPES)

The Graduate Program in Philosophy of the Federal University of Santa Catarina announces the opening of a simplified selection process for one (01) fellowship of the PNPD/CAPES Program, valid for twelve (12) months and beginning in november/2018, without extension. The selected fellowship holder will receive the payment of monthly fees of R\$ 4100.00, paid directly by CAPES. This call includes only modalities "A" (Brazilian or foreign residents in Brazil and holders of temporary visa without employment relationship) and "B" (foreigners residing abroad without employment relationship) according to items "a" and "b" of item V, Article 5, Administrative Rule No. 086, of July 13, 2013, CAPES.

The applicants should send the required documents to the e-mail of the Graduate Programa in Philosophy's office <ppgfil@contato.ufsc.br> until October 18, 2018, in electronic format, with the following subject identification of the email: "registration for PNPD scholarship".

In order to register, the applicants must submit the following documents:

- 1) Official letter presenting the application, explaining the reasons that led the candidate to choose the PPGFIL UFSC and indicating a supervisor;
- 2) Plan of activities to be carried out during the postdoctoral stage, necessarily containing: a) research project, b) indication of teaching activities and c) indication of extension activities;
- 3) Scanned copy of doctoral degree or defense certificate (diplomas issued abroad will be accepted);
- 4) Updated Curriculum Vitae or Curriculum Lattes;
- 5) Specific documents of modality A: copies of identity card and CPF;
- 6) Specific documents of modality B (foreign applicants residing abroad): copies of passport and proof of residence abroad).

The selection committee will evaluate the plan of activities, taking into consideration the merit of the research proposal and the integration with the teaching and extension activities of the Department and the Graduate Program. Candidates who achieve a grade of 7.0 (seven) or higher will be approved. In case of a tie, the commission will evaluate the Curriculum Vitae or the Curriculum Lattes. The final result, as well as the scores obtained at each stage, will be posted on the PPGFIL website until October 22, 2018. After the disclosure of the result, the approved candidate must contact the Program secretariat within 5 (five) business days, under penalty of loss of the scholarship, to provide the documents for the registration in the CAPES system.
